### BIOGRAPHY

Partner Patrick T. Jones has been a trial lawyer since 1978 and works on substantial personal injury and medical malpractice cases. Prior to opening the law firm of Jones Kelleher, Patrick was a founding partner of Cooley Manion Jones, where he managed the contingent fee practice for over twenty-five years. Throughout his career, Patrick has tried medical malpractice, product liability, civil rights, construction site, eminent domain, and general liability tort cases. His practice has also included real estate, securities, probate, insurance, and commercial litigation.

Patrick is licensed to practice law in the federal and state courts of Massachusetts, Rhode Island, and New Hampshire. Since 1983, Patrick has maintained an AV rating from Martindale-Hubbell National Law Directory, the highest rating available for legal ability and ethical standards. Since 2004, Boston Magazine surveys of 35,000 Massachusetts Bar members have rated Patrick as one of the Top 100 Super Lawyers in Massachusetts, and Patrick is rated as one of the Top 10 Super Lawyers in Massachusetts. He is a Fellow of the American College of Trial Lawyers.
